

CLARIFICATION NOTIFICATION REGARDING PROCESSING PERSONAL DATA FOR WEBSITE USERS

We, as the Çanakkale Otoyol ve Köprüsü İnşaat Yatırım ve İşletme A.Ş. (“**ÇOK A.Ş.**” or the “**Company**”) consider importance of protection your personal data. ÇOK A.Ş. processes your personal data in compliance with Personal Data Protection Law numbered 6698 (the “**Law**”) and in scope of the purposes and limitations indicated below. Accordingly, we take necessary administrative and technical precautions. In this scope, this Clarification Notification Regarding Processing Personal Data for Website Users (“**Clarification Notification**”) has been prepared in line with ÇOK A.Ş. Personal Data Protection and Processing Policy and ÇOK A.Ş. Personal Data Retention and Destruction Policy by the Company as the “**Data Controller**” in terms of Law. By way of this clarification notification, we would like to inform you about our personal data protection processes and your rights regulated under the Law.

1. IDENTITY OF THE DATA CONTROLLER

ÇOK A.Ş. has undertaken the project design, construction, operation, maintenance and repair works of the Kınalı-Tekirdağ-Çanakkale-Savaştepe Motorway Project, Malkara-Çanakkale (including the 1915 Çanakkale Bridge) Section (“**Motorway**”) project in accordance with the Implementation Contract signed with Ministry of Transportation and Infrastructure, Directorate General of Highways on 21 March 2017, as the appointed company. In relation to the personal data received from you, according to the Law and other relevant regulations we act as the “Data Controller”. You may contact us using the information given under Article 4 of this Clarification Notification.

2. THE PERSONAL DATA WE PROCESS, PERSONAL DATA PROCESSING PURPOSES AND LEGAL BASIS

2.1. In case you inquire your passes from Motorway via our website we may process your below mentioned personal data:

- a. Identity Information:** Your Turkish ID number, your tax number.
- b. Customer Transaction Information:** Your vehicle plate number.

Your such personal data is being collected and processed, limited to the purposes of management of customer relationships, pursuing your demands and complaints, carrying out the activities aimed at your satisfaction and support services provided in the after-sale services, conducting activities in compliance with the law by automatic means and electronically via website within the scope of lawful grounds of it being necessary to process the personal data of the parties of the contract provided that they are directly in relation with the execution of the contract and of it being necessary to process personal data for the legitimate interests of our Company provided that it does not infringe upon your fundamental rights and freedom.

3. TRANSFER OF THE PERSONAL DATA

In the event of any disagreement between you and our Company or any request of the governmental authorities, administration institutions or police force, your Personal Data is shared, to the extent it relates to and limited to the dispute/request, and within the scope of the Civil Procedure Law numbered 6100 and other secondary legislation with the above- mentioned authorities and our lawyers and consultants.

4. YOUR RIGHTS AS THE DATA SUBJECT AND APPLICATION METHODS

You may convey your demands encompassed in Article 11 of the Law regulating the rights of the relevant person, in compliance with the Communiqué on the Procedures and Principles of Application to Data Controller together with the documents proving your identification, to (i) Mustafa Kemal Mahallesi 2118 Cad. Maidan A Blok Kat:13 No:155 Çankaya, Ankara with wet signature by hand, or via notary public or return receipt mail, or (ii) through the registered electronic mail (KEP), secure electronic signature or mobile signature to the address of canakkale.1915@hs01.kep.tr, or (iii) through other method to be determined by the Board.

All applications to be made within this context will be accepted following ID verification to be conducted by our Company. Your applications will be finalized, according to the nature of the request, as soon as possible and within 30 days, at the latest.
